Project Selection Process

- Preliminary Screening
 - Pass/fail
 - Screening for funding eligibility criteria
- NVTA Quantitative Score
 - Incorporates HB 599 rating for <u>ALL</u> projects
- Ratio of Congestion Reduction Relative to Cost (CRRC)
 - Total project cost
 - FY2017 funding request ('NVTA Share')
- Qualitative Considerations

Related Policies

- Completion of Standard Project Agreements (SPAs) within six months of the adoption of the FY2017 Program by NVTA (Policy #16)
- Submittal of first drawdown request by June 30, 2019 by sponsors of approved projects (Policy #17)



Schedule: Previous Milestones

- Sept. 24, 2015: NVTA approves Call for Projects
- Sept. 28 thru Nov. 30, 2015: Call for Projects
- Nov. 12, 2015: NVTA approves project selection process
- Dec. 10, 2015: NVTA approves candidate project list (for HB 599 and NVTA evaluations) and policy for 'first drawdown'



Schedule: Upcoming Milestones

April

- Project evaluations complete;
- VDOT HB 599 briefings;
- NVTA approves date of Public Hearing (4/28);
- VDOT finalizes HB 599 ratings

May

- NVTA staff present project evaluations (Quantitative Scores and Congestion Reduction Relative to Cost ratios);
- NVTA approves project list for public comment (5/12).



Schedule: Upcoming Milestones

- Mid-May to mid-June:
 - Public comment period;
 - Jurisdictions host Town Hall meetings (optional).
- June:
 - Public Hearing (6/9);
 - CTB adopts Six Year Improvement Program;
 - NVTA staff present updated project evaluations.
- July:
 - NVTA adopts FY2017 Program (7/14).



Schedule: Future PPC Actions

- March 28:
 - PPC reviews status and schedule.
- April 18:
 - VDOT HB599 briefings;
 - PPC recommends date of Public Hearing.
- May 4:
 - PPC reviews project evaluations;
 - PPC recommends project list for public comment.
- Late June/Early July
 - PPC reviews public comments;
 - PPC reviews updated project evaluations (post-CTB);
 - PPC recommends draft FY2017 Program.



Public Engagement

- Subject to NVTA approval:
 - Public Hearing will take place on June 9th
- Public Comment Period will occur between May 17th and June 17th
- General approach will be similar to FY2015-16 Program
- Requests to Jurisdictions planning to host a Town Hall meeting:
 - Town Hall meetings occur during the Public Comment Period
 - Provide details to NVTA staff by April 29th for inclusion in NVTA's outreach
- TransAction Outreach:
 - Scheduled to occur between late April and late June

Summary of Candidate Projects

- 24 Projects
- \$667,949,000 requested
- \$266,700,000 estimated available (PayGo)
- All projects are subject to HB 599 evaluation and rating, including those previously rated
- HB 599 evaluations use same seven criteria as FY2015-16 Program


