Call to Order

Roll Call

The roll was called and members present or absent were noted for the record.

Minutes

Report of Nominating Committee/ Election of Officers

Ms. Vanderhye reported the Nominating Committee's slate of officers for Fiscal Year 2006:

The slate of officers as presented was moved, seconded and carried unanimously. Chairman Snyder called for nominations from the floor; there were none.

Mr. Parrish moved election of the officers by acclamation. The motion was seconded and carried unanimously.

Presentations

A. TransAction 2030 Survey

Becky Quarles of QSA Research & Strategy of Alexandria, Virginia, the firm hired to conduct the survey, noted this was a scientifically conducted, public telephone survey of 1,263 Northern Virginian adults. The survey was conducted between April 26 and May 10 so as not to be influenced by summer traffic patterns. A minimum of 100 surveys was conducted in each of the nine jurisdictions. The cooperation rate was 91% and the overall margin of sampling error was ± 2.8%.

The survey had five research objectives:

- 1) Travel Patterns
- 2) Frustrations with Travel
- 3) Transportation Priorities and Willingness to Pay
 - Priorities for transportation improvements
 - Willingness to pay for transportation improvements
 - Approval and likely use of HOT lanes
- 4) Support for Different Funding Methods
- 5) Priorities in Deciding Where to Live

Survey Conclusions include:

- Two-thirds of residents are frustrated with the trips they take and of those, almost nine in ten cited "traffic" as the reason.
- Residents across Northern Virginia are willing to pay more to fund both road and public transit improvements.
- When framed in a realistic context, Northern Virginians favor increases in the sales tax and to a lesser extent the state income tax over an increase in the gas tax.
- Northern Virginia residents are just as likely to support using highway tolls to pay for public transportation as they are for highways.
- Nearly half favor using the tolls to pay for bike paths and pedestrian improvements.
- About half support using the gas tax to pay for roadway improvements, but almost as many favor using it to pay for public transportation.
- Most Northern Virginia residents (56%) favor HOT lanes; another 3% would support them under some conditions. Only 36% oppose HOT lanes.

Authority members discussed the 2002 failed tax referendum, agreeing it was due in large part to mistrust of Richmond.

The members agreed to release the press release without quotes from Authority members.

B. VDOT Evaluation of HOV Operations on I-95/395

Due to lack of time, Mr. Morrison volunteered to make this presentation at the September meeting.

Action Items

A. Co-sponsorship of Business Transportation Action Collection

Mr. Connolly moved approval. The motion was seconded and unanimously carried.

B. Approval of Submission Deadline for FY 2007 CMAQ and RSTP Projects Mr. Connolly moved approval of the September 30 deadline. The motion was seconded and unanimously carried.

- D. Appointment of Tom Biesiadny as NVTA Staff Rep on VTrans 2025 Advisory Committee Mr. Connolly moved this appointment. The motion was seconded and unanimously carried.
