Item I: Call to Order

Chairman Zimmerman called the meeting to order at 7:06 p.m.

Item II: Roll Call



The roll was called and members present were as noted above.

### Item III: Approval of the Minutes of June 10, 2008

Mr. Connolly moved, and Mr. York seconded, the approval of the minutes of June 10, 2008, as presented. The motion carried unanimously.

### Item IV: Public Comment on Transportation Needs in Northern Virginia

After a presentation by Mr. Biesiadny summarizing NVTA's activities to implement HB 3202 and restore funding after the Virginia Supreme Court decision, the amount of funding lost and NVTA's future role, Mr. Zimmerman directed the clerk to call the speakers. Eight speakers offered a range of comments on Northern Virginia transportation issues and concerns, including comments opposing additional taxes and fees; support for dedicated funding for the Washington Metropolitan Area Transit Authority and the Virginia Railway Express; support for investments in transit; the need for NVTA to adopt a list of a finite number of major transportation projects as Hampton Roads has done; and the need to reevaluate the Authority's focus and mission.

### Item V: Report of Nominating Committee and Appointment of Town Representative

Mr. Nohe reported on the recommendation of the Town Representative Nominating Committee and moved appointment of Kristen Umstaddt, mayor of Leesburg, as the town representative. The motion was seconded by Mr. York and carried unanimously. Ms. Umstaddt was invited to join the Authority members at the table.

### Item VI. Approval of Project List for Bonus Obligation Funding

Mr. Connolly moved, and Mr. Nohe seconded, the approval of the list of projects for FY 2008 Federal Bonus Obligation funding attached to the July 8, 2008, revised report. The motion carried unanimously.

### Item VII. Approval of Deadline for CMAQ/RSTP Applications

Mr. Connolly moved, and Mr. York seconded, to establish Friday, September 26, 2008, as the submission deadline for FY 2010 Congestion Mitigation and Air Quality (CMAQ) and Regional Surface Transportation Program (RSTP) applications. The motion carried unanimously.

### Item VIII. Ratification of Agreement between NVTA and Fairfax County

Mr. Connolly moved, and Mr. Euille seconded, ratification of the agreement between NVTA and Fairfax County attached to the July 3, 2008, report for provision of funds to address NVTA's FY 2008 financial obligations.



## Additional Item: Reports from Managers of Regional and State Transportation Agencies

Mr. Catoe, General Manager of the Washington Metropolitan Area Transit Authority, addressed the criticalness of funding for Metro. He spoke about increased ridership and capital costs and the need for replacement of infrastructure (including rail cars) on a schedule consistent with its life expectancy. He discussed some of the side effects of not addressing the capital needs, as well as the need to address increased operating costs. He said Metro was able to reprioritize capital funds for FY 09 to address needs for the next few years; however, there are still unmet needs in FY 09 and beyond. He concluded that the federal government and the region must come together to invest in the system that is essential to the growth and economic viability of the area. After discussion, NVTA members expressed their support for funding the capital needs of Metro.

Mr. Dale Zehner, Chief Executive Officer of the Virginia Railway Express (VRE), spoke about funding issues and the need for the purchase of additional locomotives and a potential increase in fares. He noted that NVTA funding from HB 3202 would have allowed VRE's to purchase locomotives, expand service, address insurance requirements and address increased fuel costs. He said that trains are at capacity with standees on some of the trains at peak hours. VRE will discuss funding issues with its Operations Board in August.

Mr. Alfred Harf, Executive Director of the Potomac and Rappahannock Transportation Commission (PRTC), stated that ridership is up by 16% in the last four months with vehicles at capacity. The cost of fuel continues to be a challenge. The PRTC is drafting a coping plan which proposes a fare increase, fare indexing policy, supplementation of service hours, expedited purchases of buses and fareboxes, and other items.

Mr. Corey Hill, Chief of Transportation for the Department of Rail and Public Transportation (DRPT), gave a presentation on the Department's Total Six Year Improvement Program (SYIP) which is approved by the Commonwealth Transportation Board. He also reported on a new system in process for assessment management.

Mr. William Cutler, P.E., Assistant District Administrator at the Virginia Department of Transportation (VDOT), gave a presentation on the impacts to VDOT from SYIP funding reductions and delays and cuts in projects in the future. He provided a list of 101 projects in Northern Virginia that have been affected by cuts in SYIP funding.

#### Item IX. Update on General Assembly Activities

In a general discussion, Mr. York suggested that Northern Virginia establish a committee to investigate Northern Virginia statehood.

#### Item X. Update on Advocacy



A general discussion by Authority members ensued, in which concern was expressed with respect to the General Assembly's failure to resolve the transportation funding issue in its recent special session.

### Item XIII. Closing of NVTA Office

Consistent with guidance from the NVTA meeting in June, Mr. Mason presented a plan for the closing of NVTA office and its operations. Following discussion and a general sensing that NVTA should cease operations, Mr. Euille moved, and Mr. Zimmerman seconded, that NVTA hold an additional meeting of the Authority in September 2008 to discuss matters relating to the closing of the NVTA office and operations, with a view to adjourning indefinitely until such time as a dedicated funding source is identified. Following a question by Mr. Way and further discussion, Chairman Zimmerman clarified that a decision about meetings beyond September 11, 2008, would be made at the September 11, 2008, meeting. The motion carried by a vote of 13 to 1, Mr. Way voting "no". Chairman Zimmerman provided additional guidance that NVTA staff, in coordination with the Council of Counsels, prepare a list of activities that NVTA must legally continue to undertake and those which may be desirable for it to continue to undertake.

NVTA members expressed their gratitude to John Mason, Tom Biesiadny, the Jurisdictional and Agency Coordinating Committee, and others involved with NVTA for their time and support. Mayor Euille also expressed his thanks to the Technical Advisory Committee for their willingness to serve.

**SUBJECT:** Approval of Resolution on Reduction in NVTA Operating Activities (Item IV.)

**DATE:** September 5, 2008

#### **Recommendation:**

The Jurisdiction and Agency Coordinating Committee and Executive Director recommend that the Northern Virginia Transportation Authority approved the attached resolution regarding a reduction in NVTA's Operating Activities, due to a lack of funding.

### **Background:**

Despite NVTA's good faith efforts to implement HB 3202 (2007), on February 29, 2008, the Virginia Supreme Court ruled that the Virginia General Assembly did not have the constitutional authority to delegate its taxing powers to NVTA. During the 2008 Regular Session and a subsequent Special Session, the General Assembly was unable to agree on a new funding mechanism for NVTA. Consequently, although the Virginia Department of Transportation continues to provide NVTA with an annually \$50,000 planning grant, there is not sufficient funding to maintain NVTA's current operations. NVTA's Executive Director, the Jurisdiction and Agency Coordinating Committee and the Council of Counsels have worked cooperatively to prepare the attached resolution to implement changes to NVTA's activities to reflect current funding levels.

The resolution contains five parts. These parts are summarized as follows:

- 1. It directs that NVTA terminate its lease, close its administrative offices and transfer the functions of its Executive Director to a combination of its Finance Committee, the Jurisdiction and Agency Coordinating Committee and the Council of Counsels;
- 2. It approves a new reduced meeting schedule that will allow NVTA to continue to meet its basic statutory responsibility. This new meeting schedule proposes a December 11, 2008, meeting primarily to adopt a 2009 legislative program; approve FY 2010 Congestion Mitigation and Air Quality funds and Regional Surface Transportation Program recommendations; endorse NVTA final testimony to the Commonwealth Transportation Board; and accept NVTA's FY 2008 Audit. It also proposes a joint meeting with the Northern Virginia Transportation Commission in Richmond on February 5, 2009, primarily to discuss legislation introduced during the 2009 General Assembly session.
- 3. It temporarily suspends Article 4 subsection A of its By-laws, and establishes December 11, 2008, as the NVTA Annual Meeting for 2009, rather than January 8, 2009. This meeting would include the selection of officers for 2009.
- 4. It ratifies the letter from Chairman Zimmerman to John Mason, dated August 15, 2008, terminating the "Employment Agreement" executed on January 11, 2008.
- 5. It directs the Jurisdiction and Agency Coordinating Committee to continue its efforts on behalf of NVTA. These efforts specifically include:
  - a. finalizing testimony for the CTB's Fall Transportation Public Hearing;
  - b. incorporating NVTA's suggestions into the 2009 Legislative Program and having the program ready for consideration by NVTA on December 11, 2008;
  - c. preparing a list of recommended FY 2010 CMAQ and RSTP projects;
  - d. continuing to monitor regional transportation projects such as:
    - i. The I-95/395 HOT Lanes Project
    - ii. The Beltway HOT Lanes Project
    - iii. The I-66 Transit/TDM Study
    - iv. The Statewide Rail Plan
    - v. VTrans 2035 Plan

and prepare a status report for the December 11, 2008, NVTA meeting;

- e. approving requests to reallocate CMAQ and RSTP funds between projects that NVTA has approved in the past. Give provisional approval to reallocate funds to projects not previously approved by NVTA, subject to NVTA's concurrence at the NVTA next meeting; and
- f. continuing to coordinate regional transportation issues, based on past NVTA direction.

### - RESOLUTION -

#### REDUCTION IN OPERATING ACTIVITIES

WHEREAS, the Northern Virginia Transportation Authority ("NVTA") was created by the General Assembly in 2002 to, among other things, prepare a regional transportation plan for Planning District Eight; construct or acquire the transportation facilities included in the transportation plan; set regional transportation policies and priorities for regional transportation projects; provide general oversight of regional mass transit and congestion mitigations programs and regional transportation issues; develop regional transportation priorities and policies to improve air quality; advocate for the transportation needs of Northern Virginia; and collect and impose taxes and fees authorized by law; and

**WHEREAS,** on July 12, 2007, the NVTA did impose seven taxes and fees authorized by the General Assembly in Chapter 896 of the Code of Virginia, to be effective on January 1, 2008; and

**WHEREAS,** on February 29, 2008, the Virginia Supreme Court ruled that the General Assembly did not have the authority under the Virginia Constitution to delegate its taxing powers to the NVTA; and

**WHEREAS,** on March 3, 2008, the NVTA ceased collection of the seven taxes and fees authorized by Chapter 896 of the Code of Virginia; and

**WHEREAS**, the General Assembly has not restored any transportation funding to NVTA;

**NOW, THEREFORE, BE IT RESOLVED, THAT** effective September 30, 2008, the Northern Virginia Transportation Authority shall terminate its lease, close its administrative offices and transfer the functions of its Executive Director to a combination of its Finance Committee, the Jurisdiction and Agency Coordinating Committee and the Council of Counsels, as described in Attachment I; and

**BE IT FURTHER RESOLVED THAT** the NVTA will only meet on a reduced schedule to address its on-going statutory responsibilities, as described in Attachment II or at the call of the Chairman;

**BE IT FURTHER RESOLVED THAT** the NVTA temporarily suspends Article 4 subsection A of its By-laws, and adopts the revised FY 2009 meeting schedule described in Attachment III, including the establishment of December 11, 2008, as the NVTA Annual Meeting for 2009, rather than January 8, 2009.

**BE IT FURTHER RESOLVED THAT** the NVTA ratifies the letter from its Chairman, Christopher Zimmerman, to its Executive Director, John Mason, dated August 15, 2008, included as Attachment IV, terminating the "Employment Agreement" executed on January 11, 2008. In doing so, the NVTA expresses its appreciation to Mr. Mason for his efforts on NVTA's behalf over the past nine months.

**BE IT FURTHER RESOLVED THAT** the NVTA directs the Jurisdiction and Agency Coordinating Committee to continue its efforts on behalf of NVTA, as described in Attachment V.

### **NVTA Statutory Responsibilities Assuming No Specific Funding**

### Pursuant to §15.2 – 4833 of the Code of Virginia

The Authority shall employ a chief executive officer and such staff as it shall determine to be necessary to carry out its duties and responsibilities under this chapter.

### Pursuant to §15.2 – 4838 of the Code of Virginia

The Authority shall be responsible for long-range transportation planning for regional transportation projects in Northern Virginia. In carrying out this responsibility, the Authority shall, on the basis of a regional consensus, whenever possible, set regional transportation policies and priorities for regional transportation projects.

### Pursuant to §15.2 – 4840 of the Code of Virginia [1]

The Authority shall have the following duties and responsibilities:

- 1. General oversight of regional programs involving mass transit or congestion mitigation, including, but not necessarily limited to, carpooling, vanpooling, and ridesharing;
- 2. Long-range regional planning, both financially constrained and unconstrained;
- 3. Recommending to state, regional, and federal agencies regional transportation priorities, including public-private transportation projects, and funding allocations;
- 4. Developing, in coordination with affected counties and cities, regional priorities and policies to improve air quality;
- 5. Allocating to priority regional transportation projects any funds made available to the Authority and, at the discretion of the Authority, directly overseeing such projects;
- 6. Recommending to the Commonwealth Transportation Board priority regional transportation projects for receipt of federal and state funds;
- 8. General oversight of regional transportation issues of a multijurisdictional nature, including but not limited to intelligent transportation systems, signalization, and preparation for and response to emergencies;
- 9. Serving as an advocate for the transportation needs of Northern Virginia before the state and federal governments;
- 10. Applying to and negotiating with the government of the United States, the Commonwealth of Virginia, or any agency, instrumentality, or political subdivision thereof, for grants and any other funds available to carry out the purposes of this chapter and receiving, holding, accepting, and

administering from any source gifts, bequests, grants, aid, or contributions of money, property, labor, or other things of value to be held, used and applied to carry out the purposes of this chapter subject, however, to any conditions upon which gifts, bequests, grants, aid, or contributions are made. Unless otherwise restricted by the terms of the gift, bequest, or grant, the Authority may sell, exchange, or otherwise dispose of such money, securities, or other property given or bequeathed to it in furtherance of its purposes;

It is with regret that, on behalf of the Northern Virginia Transportation Authority and in accordance with our employment agreement with you, I must notify you that your employment with the Northern Virginia Transportation Authority will end effective September 30, 2008, or sooner as described below. This termination action is necessitated by the failure of the General Assembly to agree an approach to dedicated funding for the Authority. I recognize that you will want to complete any tasks resulting from the Authority's meeting of September 11 and to ensure an orderly closure of the NVTA office thereafter. It may be possible to conclude all necessary tasks before September 30. Accordingly, following the meeting of September 11, please notify me whether September 30 or an earlier date is the most suitable final work date to conclude your employment with the Authority.

Consistent with your proposed budget for FY09 presented at the June 12 meeting and the subsequent update of NVTA's financial posture (reflecting a positive balance through September 30, 2008) provided at the July 10 meeting, it is confirmed that you will be paid from July 1 through to your final working date at a half-day rate, to include pro rata benefits as described in your employment agreement.

My colleagues join with me in extending appreciation for your energetic and professional leadership in starting the process of establishing the Authority as an effective operating agency.

**ISSUE(S):** With departure of executive director, there is a need for signature authorization for NVTA checks.

**RECOMMENDATION:** Recommend that chairman and vice chairman be authorized to sign NVTA checks as was the procedure prior to hiring of executive director.

**PROPOSED MOTION:** Mr. Chairman, I move approval of attached resolution authorizing the chairman and the vice chairman to sign checks on behalf of NVTA for items approved by NVTA.

#### **SUMMARY:**

- Consistent with the Financial Working Group guidance, Resolution 11-08 authorized the chairman and vice chairman to sign checks on behalf of NVTA.
- Upon hiring of an executive director, Resolution 20-08 authorized the executive director to sign checks on behalf of NVTA.
- NVTA Bylaws, Article VIII, Section A, provide for normal signing of checks and drafts by the executive director or, in the absence of executive director, "those authorized from time to time by vote of the Authority".
- With the closing of operational NVTA office and departure of executive director, this

### APPRECIATION FOR JURISDICTIONAL AND AGENCY SUPPORT

WHEREAS, the Northern Virginia Transportation Authority ("NVTA") was created by the General Assembly in 2002, to among other things, prepare a regional transportation plan for Northern Virginia; construct or acquire the transportation facilities included in the transportation plan; set regional transportation policies and priorities for regional transportation projects; provide general oversight of regional mass transit and congestion mitigation programs and regional transportation issues; develop regional transportation priorities and policies to improve air quality; advocate for the transportation needs of Northern Virginia; and collect taxes and fees authorized by law; and,

WHEREAS, from 2002 to 2007, there was limited funding authorized to support the activities that NVTA was directed to accomplish and therefore the local jurisdictions and regional transportation planning and operating agencies of Northern Virginia, along with state transportation agencies, agreed to support the activities of the NVTA by contributing staff resources from their jurisdictions and agencies; and,

WHEREAS, the significant progress made by NVTA from 2002 to 2007 was underpinned by the extraordinary professional support from jurisdictional and agency staffs that resulted in annual coordination of regional transportation priorities and recommendations to the National Capital Region Transportation Planning Board, the Commonwealth Transportation Board and the General Assembly; completion of *TransAction 2030* – a long range transportation plan for Northern Virginia; coordination of allocations for discretionary funding; coordination of legislative and advocacy issues; coordination of comments and action on major transportation projects affecting Northern Virginia; and many other routine NVTA activities and actions; and,

#### **Recommendation:**

The Jurisdiction and Agency Coordinating Committee recommends that the Northern Virginia Transportation Authority approved the attached letter to Secretary of Transportation Pierce Homer expressing concerns regarding the scope of the I-66 Transit/Transit Demand Management (TDM) Study.

#### **Background:**

NVTA and the Northern Virginia localities have been requesting a multimodal study of the I-66 corridor for several years. The currently adopted Constrained Long-Range Plan (CLRP) entry for the I-66 Spot Improvements references TPB's resolution, TPB R11-2006, which states that: "Separate from the action on this TIP amendment [for preliminary engineering of spot improvements] ... NVTA asked that funding be sought for a long-range multimodal environmental document that will address the public transportation needs for the I-66 Multimodal Corridor. This document will include a comprehensive and objective evaluation of long-term public transportation needs in the I-66 multimodal corridor... As part of the multimodal environmental document, VDOT should study *value pricing and relatively low-cost traffic-operation solutions such as provision of express bus service and HOV-3* (italics added)."

The JACC understands that the I-66 Transit/TDM study is intended to fulfill this commitment. As such, the JACC believes that the study should include an examination of pricing or changes to the HOV incentives, as stated in the CLRP. The JACC also believes that operational issues, such of occupancy requirements and hours of operation should be included in the study, because these factors will impact the estimated transit and TDM usage in the corridor. Such a comprehensive approach will ensure than the I-66 Transit/TDM study will result in recommendations to maximize person throughput in the I-66 corridor.

Staff from several individual jurisdictions have discussed these concerns with Department of Rail and Public Transportation staff, but have been unsuccessful in expanding the scope of the study to include the points outlined above. Staff from other jurisdictions and several Northern Virginia transportation agencies also share these concerns. The attached letter is intended to document concerns and add NVTA's support to the need for addressing them.

### Dear Secretary Homer:

I am writing to share our concerns about the scope of the I-66 Transit/TDM study recently initiated by the Department of Rail and Public Transportation (DRPT). While we are encouraged that the state has begun this study and is providing Northern Virginia localities opportunities to participate, we are requesting that changes to high-occupancy-vehicle (HOV) incentives and pricing be included as part of this study.

As you know, Northern Virginia localities have been requesting a multimodal study of the I-66 corridor for several years. The currently adopted Constrained Long-Range Plan (CLRP) entry for the I-66 Spot Improvements references TPB's resolution, TPB R11-2006, noting that: "Separate from the action on this TIP amendment [for preliminary engineering of spot improvements] ... NVTA asked that funding be sought for a long-range multimodal environmental document that will address the public transportation needs for the I-66 Multimodal Corridor. This document will include a comprehensive and objective evaluation of long-term public transportation needs in the I-66 multimodal corridor... As part of the multimodal environmental document, VDOT should study value pricing and relatively low-cost traffic-operation solutions such as provision of express bus service and HOV-3 (italics added)." It is the NVTA's understanding that the I-66 Transit/TDM study is intended to fulfill that commitment, and as such should include an examination of pricing or changes to the HOV incentives, as stated in the CLRP.

Aside from meeting the requirements of the currently adopted CLRP, undertaking an evaluation of HOV restrictions (occupancy and hours) and congestion pricing as part of the I-66 Transit/TDM study will also ensure that person throughput is maximized in the I-66 corridor. Travel time, predictability and cost have an enormous influence on the choice users make regarding mode of travel, especially with regard to transit. Considering the potential impacts on all three of those factors that could be made with congestion pricing and/or modified HOV restrictions, it is important to include them in the project scope in order to obtain a fully accurate picture of how the I-66 corridor will function in

the future. If congestion pricing and HOV modifications are not included in the scope, the study will not adequately address the corridor's potential for additional TDM or transit use, and an opportunity to improve mobility to the greatest extent possible will have been missed.

### **Recommendation:**

The Jurisdiction and Agency Coordinating Committee (JACC) recommends that the Northern Virginia Transportation Authority approved the basis elements of testimony for the Commonwealth Transportation Board (CTB)'s Fall Transportation Meeting, in concept, and authorize NVTA's Chairman to approve any adjustments that may be necessary, due to information that may become available between now and the hearing, particularly regarding an reductions in state transportation funding levels.

#### **Background:**

Each fall, the Commonwealth Transportation Board holds public hearings around the state to receive suggestions for projects that should be included in the Six Year Program. The Northern Virginia public hearing will likely be in November. Since the NVTA will not be meeting again until December 11, 2008, the JACC is seeking NVTA's approval of conceptual the basic elements for the testimony that will be refined over the next two months. In particular, since state transportation revenues are apparently not meeting expectations, the CTB will likely be required to make additional reduction in the Six Year Program.

Any reductions will be on top of the 44 percent cuts in the Primary, Secondary and Urban Highway Program and the 10 percent reductions in transit assistance adopted by the CTB in June 2008. With this in mind, the JACC is recrafting the testimony to recognize the difficult situation the CTB faces, update local efforts in Northern Virginia, reiterate NVTA's principles and to focus primarily on non-monetary changes the CTB can implement to assist Northern Virginia.

The proposed basic elements of testimony include:

- Acknowledging the challenges that the CTB faces in trying to balance projects and revenues in the Six Year Program;
- Updating the CTB on NVTA's reduction in Operations
- Summarizing efforts that the NVTA local governments are making to raise transportation funding;
- Reiterating the NVTA's Eight Principles for Transportation Funding;
- Reiterating the affects of inflation and economic factors on the availability of transportation funding;
- Highlighting that VDOT is quickly becoming a maintenance-only agency;
- Requesting that construction projects that are funded continue to be implemented as scheduled;
- Requesting continued funding for VRE's track leases from federal funds;
- Allowing NVTA to help set priorities for federal bonus obligation funding;
- Encouraging additional training on VDOT's Chapter 527 land use review regulations;
- Considering comments from local governments and regional transportation agencies on Secondary Street Acceptance standards and Access Management Standards;
- Streamlining environmental reviews for locally administered projects;
- Addressing Northern Virginia concerns with the I-95/395 High Occupancy Toll project, including distribution of a bus only lane study and a safety study for public comment;
- Addressing Northern Virginia concerns with the I-66 Transit/TDM Study, including inclusion of incentives, operational parameters (hours and occupancy) and pricing as part of the study.

Since the CTB's public hearing will likely be two months away, the JACC requests that NVTA's Chairman be authorized to approve the final the testimony, including changes to address circumstances between now and then. If substantive changes are made to the basic elements, the JACC will return to the NVTA on December 11, 2008, to seek ratification of the final testimony.

JACC Members and I will be available at the Authority meeting on September 11, 2008, to answer questions.

The Jurisdiction and Agency Coordinating Committee is beginning to prepare for the 2009 General Assembly session. Attached is an initial list of suggested items for NVTA's 2009 Legislative Program. Although the NVTA was not successful in achieving new funding to replace the revenues originally approved in HB 3202 (2007), some of NVTA's 2008 legislative initiatives were addressed. The General Assembly passed legislation to:

- modify the VDOT revenue sharing program to clarify that amounts of less that \$1 million can be requested; that proffers can be used for 100 percent of the local match; that the highest priority for funding will be projects implemented by the local government, and that VDOT is able to assist with some phases of the projects.
- increase the limits on task order contracts (which allow contractors to be secured for multiple design tasks using a single procurement) from \$1 million to \$5 million. The limit on individual tasks was increased from \$200,000 to \$1,000,000.
- increase the limit on highway construction projects that local government can undertake using their own employees from \$300,000 to \$600,000.

Since the NVTA is not expected to meet again until December 11, 2008, the JACC is interested in receiving the NVTA's comments on the proposed items. In addition, the JACC is also interested in any other items NVTA members would like to have included in the 2009 Legislative Program.

The JACC will develop more specific information and recommendations on each of these items and submit them to the NVTA at the December 11, 2008, meeting for consideration.

## **Suggested 2008 Legislative Positions**

## **STATE**

## TRANSPORTATION FUNDING

Support additional state and regional transportation funding for highway, transit, bicycle and pedestrian improvements. (*Updates and reaffirms previous position*.)

Specifically, the NVTA seeks reinstatement of exclusive Northern Virginia revenues in the range of \$300 million annually, as well as Northern Virginia's portion of additional statewide revenues. Such revenues should be provided from stable, reliable, proven and permanent source(s). These revenues should also provide at least \$50 million annually for Washington Metropolitan Area Transit Authority capital improvements and \$25 million annually for Virginia Railway Express capital and operating expenses. Specific VRE requests include: \$25M for locomotives, \$4.5M Insurance Trust Fund contribution, \$1M operating funding for additional service (3 new trains)

In addition, the NVTA asks the General Assembly to meet the Commonwealth's statutory 95 percent share of transit operating and capital costs (net of fares and federal assistance). This would require approximately \$190 million annually in new funds for the limited transit projects and eligible operating costs included in CTB's six-year program.

## BASE REALIGNMENT AND CLOSURE (BRAC) RECOMMENDATIONS

Support the inclusion of sufficient funding in the 2009-2010 budget to ensure significant fiscal resources to address the enormous planning and transportation issues associated with the Base Realignment and Closure Commission recommendations. This is particularly critical, because the BRAC relocations will occur in 2011, and there is significant lead time required to implement needed transportation improvements. (Reaffirms previous position.)

## PEDESTRIAN SAFETY

Support revisions to Virginia's existing pedestrian legislation to clarify the responsibilities of drivers and pedestrians in order to reduce the number of pedestrian injuries and fatalities that occur each year. In particular, support legislation that would require motorists to stop for pedestrians in crosswalks at unsignalized intersections on roads where the speed is 35 mph or less. Recent events throughout the region have highlighted a growing concern for the safety of pedestrians attempting to cross streets. Many Northern Virginia jurisdictions are exploring a variety of means to effectively provide for pedestrian safety while avoiding both the potential for serious vehicular accidents and the potential for creating a false sense of security for the pedestrians. (Reaffirms previous position.)

## SECONDARY ROAD DEVOLUTION

Oppose any legislative or regulatory moratorium on the transfer of newly constructed secondary roads to VDOT for the purposes of ongoing maintenance. Also oppose any legislation that would require the transfer of secondary road construction and maintenance responsibilities to counties. (*Reaffirms previous position.*)

## **FEDERAL**

**SURFACE TRANSPORTATION PROGRAM REAUTHORIZATION** (Position Under Development)

## DEDICATED FUNDING FOR WMATA

NVTA calls upon Congress to adopt federal legislation to fully fund WMATA's capital needs, pursuant to the principles adopted by the Northern Virginia Transportation Commission. These principles are:

- 1. Legislation should seek to establish a new partnership among the federal, state, and local governments of the region to sustain the metro system that is so vital to the interests of all.
  - ◆ As noted in the 2004 report of the "Blue Ribbon Panel," the federal government is heavily dependent on Metro. About half the riders during peak times are federal workers; a substantial portion of the stations serve federal facilities; the system is vital to the functioning of Washington as a capital city, for both tourists and travelers who come to do business with the U.S. government.
- 2. Federal legislation should actually dedicate funds, not just mandate state/local dedication.
  - ◆ This means that there should be a federal revenue source (or sources) that will generate funds that can exclusively be used to fund a federal share of Metro capital and operating expenses. (Simply establishing a funding authorization level subject to annual appropriations does not constitute a federal match.)
- 3. Direct participation by the federal government in the governance of WMATA must be based on participation by the federal government as a funding partner.
  - ◆ As long as the federal government provides dedicated revenues for WMATA it should qualify for one board member. As it renews its funding, its vote on the board should also be renewed.

• If the federal government agrees to participate as a full funding partner to the same extent as the current state and local partners, then the federal government should qualify for two voting members.

This represents approximately \$150 million in additional federal funding annually to meet Metro's unfunded needs to ensure that the system can continue to operate efficiently. (Updates previous position).

## FUNDING FOR THE VIRGINIA RAILWAY EXPRESS

NVTA calls upon Congress to provide a minimum of \$50 million for the acquisition of new VRE locomotives during the remainder of the SAFETEA-LU authorization to help the Commonwealth and the region fully fund this critical capital need. Also, the NVTA supports federal legislation that would authorize and appropriate monies for expansion of VRE beyond its current operation, specifically the Gainesville-Haymarket expansion. In addition, the NVTA supports federal legislation that would authorize funding for the completion of expansion capacity demands within the existing territory as set forth in SAFETEA-LU. (Reaffirms previous position.)

## FUNDING FOR TRANSPORTATION EMERGENCY PREPAREDNESS

NVTA calls upon Congress to provide increased security funding to local and regional transportation agencies in the metropolitan Washington area. (*Reaffirms previous position.*)

## FUNDING FOR THE METROPOLITAN AREA TRANSPORTATION OPERATIONS COORDINATION (MATOC) PROGRAM

NVTA calls upon Congress to provide increased funding to transportation agencies in the metropolitan Washington area to meet MATOC objections. (New position, under review).

## **COMMUTER BENEFITS**

NVTA supports legislation that would increase the level of tax-free transit benefits employers can provide to employees above the current \$115 per month, as a way to make transit service more attractive to commuters who currently drive alone. In addition, NVTA supports legislation to permanently extend the current transit benefit to all branches of the federal government. (*Reaffirms previous position.*)

## AMTRAK RESTRUCTURING

NVTA opposes legislation that shifts the funding responsibility for Amtrak services to individual states or coalitions of states. Under such scenarios, Amtrak would likely be forced to compete for already scarce transit funding. This would be detrimental to local transit systems, particularly if additional state funding for transit is not identified. In addition, NVTA advocates that any Amtrak reauthorization legislation ensure continued

VRE access to Washington Union Station and yards. (Reaffirms previous position.)

# FUNDING FOR CONSTRUCTION OF AN I-66 TRUCK INSPECTION AND WEIGH STATION

NVTA advocates that funding be included in the Homeland Security budget for these I-66 inspection and weigh stations. (*Reaffirms previous position.*)

**DATE:** September 5, 2008

On July 16, 2008, the Transportation Planning Board (TPB) adopted an FY 2009-2014 TIP without updating the 2007 CLRP. This new TIP excluded all proposed changes to the TIP that affected regional air quality conformity which were originally approved by TPB on April 16, 2008. These conformity affecting changes included those projects that relied on anticipated Northern Virginia Transportation Authority funding. These NVTA-funded projects had to be excluded, because, during its Special Session in July, the Virginia General Assembly did not restore the Northern Virginia funding invalidated by the Virginia Supreme Court on February 29, 2008.

The TPB's July 16, 2008, action to adopt the air quality conformity neutral TIP will allow the Virginia Department of Transportation to receive approval for a new FY 2009 State Transportation Improvement Program (STIP) before the existing FY 2007 STIP expires at the end of September 2008. This will allow federal funding to continue to flow to projects statewide.

TPB staff is in the process of developing the 2008 update to the 2007 CLRP and conducting an air quality conformity analysis on this new CLRP. The recently adopted FY 2009 TIP will be amended to include funding for new projects, and/or reflect funding changes to existing projects consistent with the new CLRP. These updates to the CLRP and TIP will also exclude projects relying upon NVTA funding. This conformity analysis is expected to be complete in October 2008. The TPB is scheduled to release a new 2008 CLRP and the amended FY 2009 TIP for public comment in October, and is then expected to consider adoption of this documents in November 2008.

In addition, the TPB is beginning the process for the FY 2010-2015 TIP and 2009 CLRP. Project submissions for these documents will be due on December 5, 2008. The schedules for development of the amendments to the FY 2009-2014 TIP/2008 CLRP and the FY 2010-2015 TIP and 2009 CLRP are attached.

This memorandum is intending to provide the NVTA with a brief update on regional air quality activities.

The 2008 ozone season began on May 1, 2008. This year the Environmental Protection Agency strengthened the eight hour ground level ozone standard from 84 parts per billion to 75parts per billion. The EPA also revised the Air Quality Index used in forecasting poor air quality days to correspond to the new tougher standard. As a result, the region will likely experience an increase in the numbers of code orange air quality days. So far this season, the region has experienced four actual code red days and 15 actual code orange days. Last year, seven of these code orange days would have been classified as code yellow. There were 15 actual code orange days and no code red days in 2007.

The Metropolitan Washington Council of Governments (COG)'s Climate Change Steering Committee (CCSC) is currently reviewing its "National Capital Region Climate Action Report." At its most recent meeting on June 25, 2008, after considerable discussion, the committee decided to adopt language suggested by COG's Department of Environmental Programs staff related to conducting an air quality conformity analysis for greenhouse gases. The language reads: "Collaborate with TPB (Transportation Planning Board) to evaluate how a regional process modeled after the current regional conformity process for air quality planning might be adapted to address greenhouse gas emissions."

The COG Board of Directors is scheduled to review the draft report on July 9, 2008, and release it for member and stakeholder comments. The comment period is expected to last until September 30, 2008. The CCSC is scheduled to meet in October to consider comments received. The COG Board of Directors is scheduled to consider the final report at its November 12, 2008, meeting.

More detailed information on these and other related topics is attached. JACC members and I will be available at the Authority meeting on September 11, 2008, to answer questions.

## Additional Air Quality Information September 5, 2008

Ground Level Ozone: The metropolitan Washington region is currently in non-attainment of the National Ambient Air Quality Standards (NAAQS) for ground level ozone. The region is required to attain the standards by June 2010. A State Implementation Plan (SIP) on how the region anticipates to attain the standards by this date was submitted to the US EPA in June 2007. The SIP established new emissions limits (budgets) for transportation sector. The US EPA has yet to take action on either the SIP or the proposed new mobile source emissions budget. One of the reasons for the delay in EPA's action in the new mobile source emissions budgets is a recent court ruling that overturned a US EPA rule, Clean Air Interstate Rule (CAIR). The Washington region's SIP accounted for the benefits from the CAIR rule. The US EPA, state air agencies and MWAQC are examining the next course of action. Regional transportation planning and its air quality conformity analyses may continue to proceed using the interim emissions budgets for the mobile sector previously published by the US EPA.

Particulate Matter (PM2.5): The metropolitan Washington region is currently in non-attainment of the NAAQS for particulate matter 2.5 microns or smaller (PM2.5). The region is required to attain the standards by April 2010. A State Implementation Plan (SIP) on how the region anticipates to attain the standards by this date was submitted to the US EPA in April 2008. The SIP established new emissions limits (budgets) for transportation sector. The US EPA has yet to take action on either the SIP or the proposed new mobile source emissions budget. One of the reasons for the delay in EPA's action in the new mobile source emissions budgets is a recent court ruling that overturned a US EPA rule, Clean Air Interstate Rule (CAIR). The Washington region's SIP accounted for the benefits from the CAIR rule. The US EPA, state air agencies and MWAQC are examining the next course of action. Regional transportation planning and its air quality conformity analyses may continue to proceed using the interim emissions budgets for the mobile sector previously published by the US EPA.

Air Quality Action Days: The metropolitan Washington region has had a very active public education and call for volunteer action program for the past ten years. The program, Clean Air Partners, forecasts poor air quality days and works with businesses, organizations and individuals to encourage them to take voluntary actions that would reduce emissions of pollutants. Before 2006 the program was limited to the ozone season (May thru September) and focused on forecasting days with high levels of ozone. Since 2007, the program has expanded to include days with high level of particulate matter and spans the entire year. Poor air quality days are color coded with Orange, Red and Purple days representing increasing risks to public health and requiring increasingly more proactive actions be taken to avoid exposure and reduce emissions. In March of this year the EPA revised Air Quality Index (AQI) used to classify poor air quality days to match the new tougher eight hour ozone standards. Using the revised AQI, this year, to date, there have been 15 code Orange and four code Red days. In 2007 (with the less restrictive AQI), the region had a total of 15 code Orange and no code Red days.

<u>Climate Change</u>: The Metropolitan Washington Council of Governments (COG)'s Climate Change Steering Committee (CCSC) recently released a Draft of its "National Capital Region Climate Action Report" for stakeholder comments. The comment period is expected to last until September 30, 2008. The CCSC is scheduled to meet in October to consider comments received. The COG Board of Directors is scheduled to consider the final report at its November 12, 2008, meeting.

A large part of the report talks about Transportation and Land Use – its contribution to greenhouse gases causing climate change, forecast trends for these two in this region and opportunities to take proactive actions to reduce greenhouse gases and minimize climate change. The Transportation Planning Board intends to comment on the Draft report.

The Virginia Energy Plan, released in September 2007, set a goal for the Commonwealth to reduce greenhouse gas emissions by 30 percent by 2025. The reduction in emissions will be partially achieved through energy conservation and renewable energy actions listed in the energy plan. In December 2007, Virginia Governor Timothy Kaine established a Commission on Climate Change, to identify additional steps that need to be taken to achieve the emissions reduction goal in a report scheduled to be issued by December 15, 2008.

We ended FY08 with a positive balance of \$21,938.92 in our general and administrative fund (G&A). This balance carries over into FY09.

For FY09, by the end of September the currently projected balance is \$41,504.58. I expect this to be slightly less as there may be minor expenses over the next two weeks. Later in the fiscal year, following the audits for FY08 and FY09, projected balance is \$4,504.58. Realistically, some expenses (e.g., public hearing, reproduction costs) should be anticipated; therefore, the final balance will probably be less.

Importantly, it will be essential to ensure that expenses after September 30 are very limited to essential items.

The FY08 audit preparations are well under way. The FY09 audit will be done at the end of FY09. With my departure, Scott Kalkwarf will be responsible for coordinating audits.

### STATUS OF MAJOR TRANSPORTATION STUDIES AND PROJECTS IN NORTHERN VIRGINIA (Information as of September 4th, 2008)

#### Route 95/395 High-Occupancy Toll (HOT) Lanes PPTA

- Study website address is www.virginiadot.org/projects/const-project.asp?ID=296
- On October 24, 2006, an Interim Agreement was signed between Fluor-Transurban and VDOT for 56 miles or High-Occupancy Toll Lanes on I-95 and I-395. The interim agreement with Fluor-Transurban under the Public-Private Transportation Act of 1995 will advance the required preliminary work on the project.
- The proposed 56-mile HOT lanes project between Massaponax and Arlington will expand the existing highoccupancy vehicle (HOV) lanes and will extend HOV lanes south to Massaponax. HOT lanes allow drivers of low-occupancy vehicles to pay a toll to use HOV lanes. Carpoolers, buses and other transit operators would use the lanes for free.
- The interim agreement requires Fluor-Transurban to complete required preliminary engineering work, an operation plan including enhancements to transit infrastructure such as park-and-ride lots and bus stations, and an in-depth traffic and revenue study. Private partners will use the toll revenue to finance construction and operation of the HOT lanes, as well as to provide funding for additional transit in the corridor.
- Fluor / Transurban continues working to develop environmental, transit, and traffic study requirements, and has received (January 16, 2008) TPB formal action approving the project in the 2007 CLRP.

#### Route 495 High-Occupancy Toll (HOT) Lanes PPTA

- Study website is www.virginiahotlanes.com
- On April 28, 2005, a Comprehensive Agreement was signed between Fluor-Transurban and VDOT for 14 miles
  of the Capital Beltway. Fluor is the contractor and Transurban is the Toll Operator and Investor. The
  Comprehensive Agreement includes the development, design, finance, construct, maintenance and operation of
  HOT lanes on the Capital Beltway.
- The project includes adding four General Purpose Lanes to the outside in each direction of the Capital Beltway generally located between Old Dominion Drive in the north and Phase VIII of the Springfield Interchange in the south. The typical section consists of a continuous 12-lane system made up of eight general-purpose lanes and four HOT lanes.
- A subsequent Environmental Summary document is being prepared to update environmental impacts due to design refinements since the Environmental Reevaluation.
- A Design Public Hearing was held on May 20 and 21. The public comment period ended June 5. Comments are being compiled and responded to. This material, along with revised design, will be presented to the Chief Engineer for his review and concurrence.
- A resolution in support of the Project was considered by the Fairfax County Board of Supervisors on June 30.
   The Board of Supervisors voted to conditionally support the Project.
- Selective Clearing of Staging Areas within existing VDOT Right of Way is underway.
- Financial Close occurred on December 31, 2007.
- Heavy construction was scheduled to begin July 2008. Early start area will be the Little River Turnpike Interchange.
- An Amended and Restated Comprehensive Agreement (ARCA), as well as sub-agreements focused on Technical Requirements, Performance Points and Joint Operating and Maintenance Protocols, were agreed to by FTU and VDOT in late December, 2007.
- FTU is now advancing design in preparation for Design Public Hearing. Design is being reviewed by VDOT via a series of Technical Review Meetings arranged by technical discipline. The design as of April 4, 2008 will be placed in the public arena at VDOT facilities and online for public review prior to the Design Public Hearing.
- The Detailed Proposals, Comprehensive Agreement and additional information may be found on the project web site located at <a href="https://www.virginiadot.org/projects/ppta-defaultHOTLANESCapitalBeltway.asp">www.virginiadot.org/projects/ppta-defaultHOTLANESCapitalBeltway.asp</a>. A new website, www.virginiahotlanes.com, is also in development by FTU.

#### Capital Beltway South Side Mobility Study (CBSSMS)

- Study website address is <u>www.southsidecapitalbeltway.org</u>
- VDOT & Maryland SHA jointly undertaking 2 Beltway mobility studies to identify possible measures for congestion reduction; MdSHA study examining west side of Beltway (VA 193 to I-270 & along I-270 to I-370); VDOT study examining Beltway from MD 5 (Branch Avenue) west to Springfield Interchange;
- CBSSMS proposes to examine Beltway lane geometry between WW Bridge and Springfield Interchange ("gap" study) to identify discontinuities, and develop recommendations for near-term & long-term modal use of median lanes on Bridge (structurally designed to support heavy rail loading);
- CBSSMS findings and recommendations will help guide design of Beltway / US 1 interchange ramps;
- Study includes 2 phases: Phase 1 (collection of completed studies and transportation recommendations & examination of modal recommendations) is essentially complete; Phase 2 includes travel demand forecasting and result in mobility suggestions.
- Since there will not be connecting HOV / transit systems in place on both sides of the bridge when the remaining span of the bridge opens, the Maryland and Virginia Secretaries of Transportation have agreed that the median lanes will be initially striped out and used only for incident management or maintenance of traffic, per the FHWA Record of Decision. A separate follow-on study to determine transit ridership demand has been suggested in order to provide data needed to pursue any FTA New Starts initiative determined to be feasible. Study team consultant staff are coordinating with MWCOG staff regarding use of the new regional travel demand model to develop initial market demand information for use in any follow-on study.
- A Technical Committee meeting was held March 6<sup>th</sup> to discuss the planned transit demand market study. The regional travel forecast model (Version 2.2) has been obtained from MWCOG and is being used in the market demand study now underway by the consultant (transit staff in the Parsons Brinckerhoff New York Office). This demand study is anticipated to be completed in the fall, 2008.

#### U. S. Route 1 Location Study

- VDOT's NoVA District is managing the study.
- Project is broken into three sections for environmental analyses and documentation.
  - Project A: South of Russell Road to Route 123 (Prince William County)
  - Project B: Route 123 to Telegraph Road (Prince William and Fairfax Counties)
  - o Project C: Telegraph Road to Capital Beltway (Fairfax County)
- CTB Approved Project B on April 15, 2004. Federal Highway Administration issued Finding of No Significant Impact (FONSI) for Study B on May 28, 2004.
- CTB Approved Project A on July 15, 2004. Federal Highway Administration issued Finding of No Significant Impact (FONSI) for Study A on March 19, 2007.
- Project C is on hold pending the conclusions of a separate transit study.
- Cost estimates for final reports for Projects A and B are underway.

#### **Dulles Corridor Metrorail Project**

- The project website address is www.dullesmetro.com.
- The Dulles Corridor Metrorail project is moving ahead with additional utility and site preparation work and the acquisition of rights-of-way in keeping with the guidelines set forth in the May 12 decision by The Federal Transit Administration (FTA) to move the Dulles Corridor Metrorail Project into the Final Design stage of FTA's New Starts Process. FTA committed \$158.7 million to be used for project design and engineering, additional utility relocations, acquisitions of rights-of way, project administration, and the design of rail cars.
- Washington Gas has completed the bulk of its relocations in the service roads along the south side of Route 7
   between Gosnell Road and Route 123 in Tysons Corner. Lane Construction is now doing additional utility work. So

far, utility relocation traffic impacts have been minimal. Access to all businesses has been, and will continue to be maintained throughout all utility relocations. Communications outreach efforts with business executed by the Airports Authority and Dulles Transit Partners, the project's design-build contractor, have been intensive and daily to ease impacts of work in the service roads. All utilities are being placed below ground.

- The project team is working on request for a Full Funding Grant Agreement. The project is seeking \$900 million in federal funds. FTA's recent approval for entering Final Design is a key step in FTA's New Starts process.
- The project team has and will hold more than 15 outreach sessions leading to Fairfax County's anticipated approval of stations' sites as being in accord with the county's Comprehensive Land Use Plan.
- The Metropolitan Washington Airports Authority and Dulles Transit Partners, a partnership of Bechtel and Washington Group Inc., signed the design-build contract for the 11 mile extension on June 19, 2007. Phase 1 of the extension includes an aerial alignment through Tysons Corner, the long-standing locally preferred route. The project is being managed by the Airports Authority.
- When completed, the 23-mile extension of the existing Metrorail line will run from just west of the East Falls Church Metro Station to Route 772 in Loudoun County. The project will be built in two phases. The first will connect East Falls Church with Wiehle Avenue and includes four stations in Tysons Corner. Phase 2 runs from Wiehle Avenue on the Eastern edge of Reston through Washington Dulles International Airport westward into Eastern Loudoun.
- All stations are served by pedestrian access bridges and have escalators and elevators in the bridge access structures and in the stations.
- Phase 1 is expected to begin revenue service in 2013.

#### **I-66 Spot Improvements**

- The study web site is located at <u>I-66spotimprovements.com</u> and is also linked via VDOT's web site under Projects and Studies in Northern Virginia.
- There are three spot improvements identified to ease the congestion within the study area:
  - o Extension of the Fairfax Drive on-ramp to Sycamore Street
  - Extension of the Washington Blvd on-ramp to the Dulles Airport Access Road
  - Extension of the Lee Highway/Spout Run on-ramp to Glebe Road
- The right of way verification has been completed and may be viewed upon request at Suite 900 in Arlington Co and the plan room at VDOT (Chantilly). Contact Tamara Ashby in Arlington County at 703-228-3833 or Jeff Daily in VDOT at 703-383-2205.
- IDEA-66 has evolved into I-66 Spot Improvements, the preliminary engineering phase of the implementation of three spot improvements on I-66 westbound inside the Capital Beltway. For more information about the I-66 spot improvements, please visit our new website at <a href="https://www.l-66spotimprovements.com">www.l-66spotimprovements.com</a>.

#### Woodrow Wilson Bridge Project

- Project website address is www.wilsonbridge.com/
- The Wilson Bridge Project is comprised of a 7-1/2 mile Beltway (I-95/I-495) reconstruction, including the replacement of the 40-year old, 6-lane, one-mile long bridge to a 12-lane bridge. The project also includes reconstruction of four interchanges: Telegraph Road and U.S. Route 1 in Virginia, and I-295 and MD Route 210 (Indian Head Highway) interchanges in Maryland.
- US Route 1 Interchange: Of the 9 contracts, six have been completed and two are under construction, with the last US Route 1 contract, the Jones Point Park contract, not due to be advertised until 2009. Traffic adjustments continue at the US Route 1 interchange as interim and temporary ramps are located and shifts are made to advance the construction. The new southbound Route 1 Bridge opened to traffic during the weekend of June 7,. 2008, one week ahead of the full incentive date for the contractor.
- Telegraph Road Interchange: Of the 3 contracts, two are complete (VB-1 and VB-5), and one (VB-2/3/6) is 9% complete. The VB-2/3/6 contract includes grade separated improvements south of the beltway that were not in the original plans. These improvements add significant value and extend the WWB program completion to 2013.
- In aggregate, construction for the entire WW Bridge program (including VDOT, MSHA and DDOT elements) is

- 82% complete. The switch to open the Inner Loop Local lanes started on Friday, May 30 and was complete by Sunday, June 1, 2008. Over the remaining months of 2008, traffic <u>is scheduled to</u> shift to its final alignment with the opening of through lanes on the Inner Loop and Outer Loop Bridges.
- Public presentation materials and construction schedule graphics have been added to the website; see www.wilsonbridge.com/updates.htm
- This period, the project won its third ARTBA National Quality Award (2004, 2005 and 2008) for Environmental Excellence as well as the ASCE OPAL Project of the Year award.

#### I-66 Multimodal Transportation & Environmental Study (outside Beltway)

- Study website is www.virginiadot.org/projects/studynova-rt66.asp.
- Funding was obtained to re-start the study; TIP/STIP approvals were obtained. VDOT obtained FHWA
  authorization to access the funds, and the project was reopened.
- Study manager updated study approach (including consideration of HOT lanes per the 2004 General Assembly), determined data needs and developed study timeline.
- The project study is in early stages of DEIS "re-start"; an overall scope of work and schedule is in development.
- FHWA revoked the Notice of Intent (NOI) for this project in May 2008 due to inactivity; initiating coordination with FHWA to determine proper course of action for restart; another NOI will be required for the project restart.

#### **Tri-County Parkway Study**

- Study website address is <a href="www.virginiadot.org/project/tcp.asp">www.virginiadot.org/project/tcp.asp</a>
- Proposed termini for the TCP Study includes a northern terminus at the intersection of US 50 and Route 606 (Loudoun County Parkway, formerly, Old Ox Road), and a southern terminus at the VA 28/VA 234 Bypass Interchange.
- On November 17<sup>th</sup>, 2005 the Commonwealth Transportation Board approved the West Two Alternative as the location for the Tri-County Parkway. The West Two alternative begins at the I-66 and Route 234 interchange and ends at Route 50 in Loudoun County.
- Based on alignment shift, the following tasks need to be completed before FHWA can issue a Record of Decision (ROD): complete 106 Process; DEIS Reevaluation; review/ revise Final Environmental Impact Statement (FEIS), FHWA legal sufficiency; FEIS approval/printing/distribution.
- Project Manager will be updating project schedule to incorporate remaining tasks and new tasks associated with alignment shift.

#### Route 28 improvements – Public-Private Partnership Act (PPTA) project

- The PPTA team currently maintains a web page on the project at www.28freeway.com
- The proposed improvements on Route 28 include design and construction at 6 interchanges: Waxpool Road, Sterling Boulevard, Old Ox Road, Barnsfield Road, McLearen Road, and Westfields Boulevard; and design and construction of several parallel road segments including Davis Drive, Loudoun County Parkway, Centreville Road, and Pacific Boulevard. All 6 interchanges were opened to traffic by December 2006.
- Design and construction of four additional interchanges at a total cost of approximately \$111 Million is now underway, with construction to be completed by 2009 as follows: Nokes Boulevard, full clover interchange; Innovation Avenue, partial interchange; Frying Pan Road, trumpet style interchange; and Willard Road, urban diamond interchange.

#### **Summary Notes:**

Chairman York called the meeting to order at 6:48 pm.

Mr. Mason presented a short briefing on the one item for action – approval of an auditor for FY08. He explained that state law requires an annual audit and that it was advantageous to "piggy back" on the Northern Virginia Transportation Commission's contract with PBGH. As NVTC's contract with PBGH was competitively bid, approval would be consistent with NVTA interim procurement policy.

Ms. Pankak moved to approve the recommendation to have PBGH conduct the audit of NVTA's FY08 financial records. The motion was seconded by Mr. Greenfield and unanimously adopted.

As Chairman of the Northern Virginia Transportation Authority, I am writing you to support your efforts to secure legislation to provide dedicated Federal funding for the Washington Metropolitan Area Transit Authority (WMATA).

NVTA has long supported dedicated funding for WMATA, because we recognize the important role WMATA plays, not only for the citizens of the region, but also for the Federal government. Nearly half of Metrorail's peak period riders are Federal employees.

One of the strongest pieces of evidence of WMATA's critical role is the recent ridership growth experienced, as gas prices have skyrocketed. Metrorail is now routinely carrying over 800,000 passengers per day.

Unfortunately, as ridership has grown, the need for investment in the system has become even more obvious. Equipment failures and delays have become more frequent, and WMATA has not always been able to accommodate everyone who would like to use the system.

It is important that all of WMATA's partners, including the Federal government, form a new partnership to address WMATA critical infrastructure needs over the next ten years.
