



LETTER FROM THE CHAIR

he Northern Virginia Transportation Authority recognizes in a region as diverse as ours, reducing congestion and improving the quality of life of all residents by decreasing time spent commuting requires providing people with multiple transportation options. In 2022, NVTA truly delivered. For the first time in NVTA's history, NVTA simultaneously adopted the FY2022-2027 Six Year Program and the long-range transportation plan for Northern Virginia, TransAction. These accomplishments incorporated all transportation modes and are a testament to building momentum to create a more equitable, sustainable and safer transportation network in a connected region.

I'm so proud that with my colleagues on the Authority, we unanimously adopted the FY2022–2027 Six Year Program, investing nearly \$625 million in multimodal ransportation projects to bolster the economy and significantly.

improve Northern Virginians' quality of life. The adoption marks NVTA's sixth funding program and was a wonderful way to

commemorate the Authority's 20th anniversary!

When planning for the region's transportation future, NVTA understands the diverse needs of Northern Virginia. There is no one solution that can solve all transportation concerns, nor can one entity provide all the answers. As population and employment continue to increase, it is imperative for the NVTA and our partners within the region and beyond work collaboratively to enhance mobility, increase accessibility and prioritize long-term resiliency to support the rapid growth.

Planning and investing in the future of Northern Virginia's regional transportation network is never completed without seeking feedback from the public. In the spring and late summer of this year, the NVTA held two public comment periods asking residents from around the region for input on transportation priorities and projects encompassing transit, bike and pedestrian facilities, roadway, transportation technologies, and more. We are grateful for every comment received, as this feedback is an important part of the update process.

Finally, as we look ahead to 2023, NVTA and its member jurisdictions and regional partners continue to keep the protection and restoration of the Authority's revenues top of mind as part of their legislative program priorities. The region's transportation needs are vast, and it is imperative that the funding to adequately address them are protected. It is vital for the NVTA's revenues to be restored and preserved so we can continue to make regionally impactful investments now and well into the future.





Understanding the Region's Transportation Needs



When looking out to 2045, 1.3 million commute trips (76%) starting in Northern Virginia will remain in NoVA. 17% will have a destination in Washington, D.C., 6% will have a destination in Maryland, and 1% will have a destination in other parts of Virginia.

76% of 2045 commute trips by Northern Virginia residents will have a work destination in Northern Virginia

It takes a region.

The 424 candidate regional projects identified in the Plan exceed the NVTA's expected funding available through 2045. Other funding sources, including federal, state, local, and private dollars, may be available to help close the gap. Regional collaboration and the ability to work beyond jurisdictional lines is key to keeping the D.C. metropolitan area moving.

With forecasted population and employment growth through 2045, investing in transportation infrastructure with a multimodal approach is essential, as no single project, program, policy or mode will address all the region's transportation needs.
