


AUTHORITY STRUCTURE

leven years is a long time to do anything. But that's how long ago it was that I was first told (not asked) that I was going to become Chairman of the Northern Virginia Transportation Authority. It was not considered an important job at the time. The NVTA had been relegated to a small, obscure planning organization with big dreams that someday Northern Virginia would benefit from long-term, sustainable and dedicated revenues to relieve congestion in our region. I would tell anyone who would listen about our plans to get Northern Virginians home to their families faster. Little did I know that four years after becoming Chair of the Authority, Virginia would pass truly landmark legislation that would provide the funds needed to make traffic move a little more smoothly in the region.

With the passage of HB 2313, the NVTA suddenly transformed into the most high-profile transportation organization of its kind in the country.

Suddenly, the planning work that we were already doing had to become much more sophisticated, and we needed to quickly develop a robust project evaluation process. We were developing financial accounting systems, public outreach strategies, and transparent processes to ensure that the responsibility with which we had been entrusted, immediately began delivering positive results for the problem that most adversely affects the quality of life for the people that we were chosen to represent. I could not be prouder of, or more thankful to, the literally hundreds of individuals with whom I've had the pleasure of working in order to see that the promises which have been made, are promises that are kept.

I cannot begin to express my gratitude to our Executive Director, Monica Backmon, who has led an incredibly talented staff for the past five years. She has not only overseen the work that we do at the Authority, but she has also been responsible for the professionalism and integrity for which the NVTA is well-known and well-respected. Along with Chief Financial Officer, Mike Longhi, and our former Executive Director, John Mason, the NVTA has benefitted from the efforts and talents of some of the best people with whom I have ever had the pleasure to work.

As I look toward leaving the chairmanship of the NVTA at the end of 2019, I am astonished by everything that we have accomplished, including: the development of what I truly believe to be

the best long-term transportation plan in America, TransAction; the implementation of our inaugural six-year funding program; our three AA+ bond ratings; the numerous groundbreakings and ribbon cuttings that I have attended; and the thousands upon thousands of hours that Northern Virginians have spent at home with their families, rather than stuck in traffic, thanks to the congestion relief efforts and multimodal improvements that we have been able to facilitate with our member jurisdictions and regional partners. I am grateful for every moment spent doing this work. Looking back, 11 years doesn't seem like very much time at all.

NVTA initiated Regional Investment Conversations, allowing investment professionals from member jurisdictions to share insights and discuss market trends.

For the first time, NVTA co-hosted a Joint Northern Virginia Spring Transportation Meeting and Open House with regional partners at VDOT, DRPT, VRE and the Northern Virginia Transportation Commission. Featured panelists included Authority members, Marty Nohe, NVTA Chair and Prince William County Coles District Supervisor, Helen Cuervo, VDOT NOVA District Administrator, Mary Hynes, Governor's Appointee and CTB Member, Jennifer Mitchell, DRPT Director, and Katie Cristol, Arlington County Board Member.

NVTA re-established the Joint Public Information Officer Meetings to collaborate with communicators from member jurisdictions, agencies and regional partners, on the best ways to inform residents about transportation projects impacting their communities.

Driven by InNoVation

In March, NVTA hosted a sold-out Annual Northern Virginia Transportation Roundtable, in partnership with ITS Virginia. Thought-leaders and trend-setters gathered to discuss innovation in transportation and the impact of future technologies on the region's transportation network.

The Transportation Technology Committee (TTC), comprised of industry and government leaders, met for the first time in January. The TTC advises NVTA's Executive Director on policies impacting the region, as well as the latest transportation technologies that align with the vision of the Authority.

NVTA announced the kick-off of the Regional Multimodal Mobility Program (RM3P), in partnership with the Commonwealth, which awarded NVTA \$15M to develop the

program. The project will address the region's congestion and accessibility challenges using a range of technologies.

Monica Backmon, NVTA Executive Director, was a Northern Virginia Transportation Technology Panelist at the ITS Virginia Annual Conference in Richmond, VA in May 2019. She spoke to a full room of attendees about the importance of taking a multimodal regional approach to tackle congestion.

NVTA provides a regular digest of transportation technology news and trends through a bi-monthly newsletter to keep elected officials, transportation experts, D.C. Metro residents and other subscribers informed.

EVENTS AROUND THE REGION







In February, NVTA and the Northern Virginia Transportation Alliance co-hosted a Forum on the Economic Impacts of Transportation Investments at the Northern Virginia Association of Realtors that brought experts in transportation, real estate, heavy construction and business together to discuss the economic benefits of the Authority's \$3B in regional funding of transportation projects.

Monica Backmon, NVTA Executive Director, participated in a panel discussion at the annual Northern Virginia Chamber of Commerce's State of Transportation event in August. Ms. Backmon joined fellow panelists Shannon Valentine, Virginia Secretary of Transportation; Ed Mortimer, VP Transportation and Infrastructure, U.S. Chamber; and Mike Stewart, VP and Airport Manager, Washington Dulles International Airport.

In August, Phyllis Randall, Chair, Loudoun County Board of Supervisors and Vice-Chair of the Authority, and Justin Wilson, Mayor, City of Alexandria and Authority member, participated on a panel at the 4th Annual Northern Virginia Elected Leaders Summit, hosted by the Arlington Chamber of Commerce. A variety of topics were discussed, including transportation and fostering economic growth.

Total Multimodal Transportation Project Milestones:







The Authority celebrated several milestones in 2019 that showcase how NVTA-funded projects expand across Northern Virginia and impact motorists, transit riders, cyclists and pedestrians alike.

On January 23, 2019, NVTA began the new year with a groundbreaking on the OmniRide Western Maintenance and Bus Storage Facility in Prince William County. Upon completion, OmniRide's bus capacity will expand and improve on-time performance, add more options for commuters on the I-66 corridor and reduce congestion.

On September 9, 2019, the Virginia Railway Express (VRE) Slaters Lane rail crossover project in the City of Alexandria was completed. The project's completion means improved freight and passenger train capacity and improved train fluidity between VRE's Crystal City and Alexandra stations.

In 2019, three intelligent transportation system (ITS) projects were completed in the City of Alexandria. ITS technologies are enhancing the transit network by improving reliability, providing faster service and reducing traffic congestion.

With the cutting of a ribbon on May 20, 2019, NVTA and the City of Fairfax celebrated the completion of the Northfax Intersection, improving vehicular traffic flow, as well as pedestrian and vehicle mobility.



CELEBRATIONS AND MILESTONES:

RIBBON CUTTINGS, GROUNDBREAKINGS AND PROJECT COMPLETIONS CONTINUED











A Route 7/Leesburg Pike widening project was celebrated with a groundbreaking on June 13, 2019 in the Tysons corridor in Fairfax County. The project includes adding a third lane to Route 7 in each direction from Reston Avenue to Jarrett Valley Drive, building shared-use paths along both sides, and replacing and raising the bridge over Difficult Run.

On August 26, 2019, NVTA and the City of Falls Church broke ground to kick off the West Falls Church & Joint Campus Revitalization District Multimodal Transportation Project, which will reduce congestion, offer expanded travel choices, and improve safety for pedestrians, cyclists, transit riders and motorists.

On October 9, 2019, a fall ribbon-cutting ceremony was co-hosted by NVTA and Prince William County to celebrate the completion of Route 28 from Linton Hall Road to Fitzwater Drive. The project includes a widened roadway, a multi-use trail and sidewalk on both sides, new bridges over Kettle Run and traffic signal reconstruction.

On October 15, 2019, NVTA joined the Town of Leesburg, Loudoun County, VDOT and several elected officials to celebrate the start of construction on the Route 7 at Battlefield Parkway Interchange project, which will reduce congestion, allow Route 7 to become a limited access freeway through the Town of Leesburg Corporate Limits, and help pedestrians and cyclists cross Route 7 safely by providing a bike trail connection to residential and commercial/retail areas of the Town of Leesburg.

The final groundbreaking of the year occurred on December 19, 2019, in the City of Alexandria, where the start of construction on the Potomac Yard Metro Station was celebrated in the National Landing area. Hundreds of project partners and stakeholders attended the event, including elected officials such as Governor Ralph Northam; representatives of many federal, state and regional agencies; and members of the community.

FY2020-2025 SIX YEAR PROGRAM UPDATE

NVTA kicked off the FY2020-2025 Six Year Program Update on July 1, 2019, with a Call for Regional Transportation Projects for fiscal years 2024 and 2025 regional revenue consideration. On September 27, 2019, all applications were due, and NVTA staff began a comprehensive evaluation process.

During the October 10, 2019 monthly business meeting at NVTA's offices, the Authority was presented an overview of total regional transportation project applications received and resources available. 13 Northern Virginia jurisdictions and agencies submitted 46 applications to NVTA for funding consideration, with a combined request of approximately \$1.7 billion. NVTA expects to allocate at least \$400 million on projects throughout Northern Virginia. Although \$400 million is a significant amount of money, this funding cycle will be NVTA's most oversubscribed program to date.

In spring 2020, the Authority will release a list of candidate regional transportation projects and evaluations as part of the FY2020-2025 Six Year Program. A public comment period, as well as an Open House and Public Hearing hosted by the Authority, will also occur in spring 2020.

The Six Year Program Update is anticipated to be adopted by the Authority in June 2020.
