I. Call to Order

II. Approval of Meeting Summary

• <u>Motion to approve the minutes of the November 14, 2019, meeting of the GPC</u> was made by Mr. Minchew, seconded by Chairman Nohe, with abstentions from Board Member Cristol and Chair Randall. Motion passed.

III. Adoption of the 2020 Legislative Program

Ms. Backmon, Executive Director Ms. Baynard, McGuireWoods Consulting, LLC

- ✓ Ms. Baynard reviewed the changes to the draft 2020 Legislative Program since the last meeting noting:
 - Stronger statement was added regarding restoration of Long-Term Funding to the Authority based on Mayor Parrish's suggestion.

- ✓ Chair Randall commented that Loudoun County has the restoration of NVTA funding as one of the top priorities in the adopted Legislation Program.
- ✓ Chair Randall inquired about steps GPC members have taken in their jurisdictions regarding their Legislative Program and spreading the message for NVTA funding restoration?
- ✓ Board Member Cristol and Mayor Meyer noted their Legislative Programs had restoration as one of the top priorities.
- ✓ Ms. Baynard noted that the SmartScale section was updated to emphasize multimodal projects which mitigate traffic congestion relative to cost. She also noted that the statewide gas tax is part of the Transportation Budget Plan.
- ✓ Ms. Baynard discussed the 2020 General Assembly Leadership Positions.
- ✓ Mr. Minchew discussed his resignation letter to Speaker-Elect of the House from the Northern Virginia Transportation Authority as of November 27, 2019, noting it enables the Speaker-Elect to make a smooth transition.

Motion to approve the adoption of the 2020 Legislative Program, was made by Board Member Cristol, seconded by Mayor Meyer. Motion passed unanimously.
