

Rolling Road Widening: Hunter Village Drive to Old Keene Mill Road

Project Description

This project involves widening Rolling Road (Route 638) from a two to a fourlane divided roadway between Hunter Village Drive and Old Keene Mill Road, with pedestrian and bicycle facilities. In addition to widening Rolling Road, the project involves the following improvements: implementing access management by constructing a median on Rolling Road between Viola Street and Kenwood Avenue ; constructing dedicated left turn lanes at major intersections; constructing an additional

northbound left turn lane at the Old Keene Mill Road intersection ; installing a traffic signal at the intersection of Rolling Road at Greeley Boulevard; providing storm-water management facilities; and installing a shared-use path. The project will reduce congestion, enhance safety for all users, provide continuity from both the south and north directions, and improve access to points east and west while planning to meet future traffic demands.
