## TransAction Update Open House

December 4, 2019

The Northern Virginia Transportation Authority will host an Open House for firms to receive preliminary information and offer comments for an upcoming Request for Proposals (RFP) related to the next update to Northern Virginia's Regional Transportation Plan known as TransAction. The RFP will be for a technical services contract which, as a minimum, will include the following in the scope of work:

- **TransAction update** – TransAction, the long-range transportation plan for Northern Virginia, is updated every five years in order to identify regionally significant transportation improvements that will address future transportation needs throughout the region. The TransAction update will be used as a guide for NVTA's future funding programs and projects. The current TransAction Plan was adopted in October 2017. - **Six Year Program (SYP) update** – NVTA issues a Call for Regional Transportation Projects every two years to initiate an update to its SYP. Project recommendations are based on a comprehensive project evaluation process comprising quantitative and qualitative components, and public comment.
- **Other technical services as needed.**

The selected consultant team will provide technical services including multimodal transportation planning and modeling, cost estimation, data analytics, GIS, market research, public engagement, website and social media production/management, and reporting. The period of performance of the technical services contract is expected to be five years.

Potential prime consultants and sub-consultants with relevant skills are welcome to attend.
