Northern Virginia Transportation Authority Seeks Public Comment on 41 Candidate Projects for FY2020-2025 Six Year Program

Northern Virginia, March 13, 2020 – The [Northern Virginia Transportation Authority](https://thenovaauthority.org) (Authority) has released for public comment, 41 candidate projects and related information for its FY2020-2025 Six Year Program. Today, through 11:59 p.m. May 24, 2020, the Authority invites the public to learn more about and comment on the candidate projects under consideration for funding. The projects being evaluated cover multiple modes of transportation, including roadways, transit and pedestrian/bicycle pathways.

Submitted by 13 Northern Virginia localities and agencies, the candidate projects, which total approximately \$1.44 billion, are regional and multimodal in nature. The Authority anticipates adoption of the FY2020-2025 Six Year Program this summer.

An Open House and Public Hearing on candidate projects will be held on May 14, 2020 at NVTA's offices, located at 3040 Williams Drive, Suite 200, Fairfax, VA 22031. The Open House will start at 5:30 p.m. and the Public Hearing will commence immediately following a 7:00 p.m. presentation on the Six Year Program Process.

The Authority will not act on the FY2020-2025 Six Year Program after the Public Hearing on May 14th, but will continue to receive comment through 11:59 p.m. May 24, 2020. The Authority is anticipated to adopt the Six Year Program Update at the Authority Meeting on July 9, 2020.

The Open House will give attendees an opportunity to meet with NVTA staff one-on-one and ask questions prior to the Public Hearing. Pre-registration is open for those who would like to speak at the Public Hearing and provide public comment to members of the Authority. Each speaker will have three minutes to provide comments on the FY2020-2025 Six Year Program candidate projects. Pre-registration is strongly recommended and can be done in one of three ways:

The NVTAs was created by the General Assembly on July 1, 2002, to offer a common voice for Northern Virginia on transportation issues confronting the region. The Authority is made up of nine jurisdictions including: the counties of Arlington, Fairfax, Loudoun and Prince William; as well as the cities of Alexandria, Fairfax, Falls Church, Manassas and Manassas Park. The Authority is responsible for updating Northern Virginia's long-range transportation plan, TransAction, and since 2014 manages approximately \$273 million annually in public funds for transportation projects designed to provide congestion relief throughout Northern Virginia.
