

Project Description

The project will widen approximately 1 mile of Route 7 between I-495 and I-66 creating one lane in each direction by widening to the outside with a median. Existing lanes will be shifted outside to provide a wider median to be used for future Bus Rapid Transit (BRT). This project includes shared used paths on both sides. Intersection improvements will be required at 5 signals to facilitate the widening. Access management, including the elimination of service roads and allowing direct access from driveways to Route 7, will also be included. The separation of vehicular traffic and the installation of shared use paths will create a safer environment that is accessible to all users. The future implementation of BRT will enhance regional sustainability by reducing congestion and getting more people out of automobiles.
