## **ACTION ITEMS**

# 3. Approval of March 14, 2024, Meeting Summary Minutes

**Chair Randall** 

✓ Chair Randall made a motion to approve the summary meeting minutes, seconded by Chair Jefferson. The motion passed unanimously with Mayor Rishell abstaining.

## 4. Adoption of the FY2025 Local Distribution Fund Budget

Mayor Rishell, Finance Committee Chair

A video describing the differences between the Local Distribution Fund and Regional Revenue Fund budgets was displayed for the members and public.

- ✓ Chief Financial Officer Michael Longhi recapped the high points of the Local Distribution Fund Budget, noting this budget accounts for the monthly Local Distribution Fund, or 30%, disbursements.
- ✓ Mr. Longhi reminded Authority members that the funds are restricted as required by the Code of Virginia and actual distributions to each jurisdiction will be contingent upon their timely completion of the annual certification process. Distribution of the funds will be determined by the actual revenues received based on direct and accredited transactions within the jurisdiction.
- ✓ Mr. Longhi also stated that all prior fiscal year accruals and Commonwealth revenue adjustments of Local Distribution Fund revenues will be distributed to the appropriate jurisdiction in FY2025 in accordance with the Code of Virginia.
- ✓ Mayor Rishell made a motion, seconded by Chair Randall, to approve the Local Distribution Fund Budget as presented. The motion was approved unanimously.

## 5. Adoption of the FY2025 Regional Revenue Fund Budget

Mayor Rishell, Finance Committee Chair

- ✓ Chief Financial Officer Michael Longhi recapped the high points of the Regional Revenue Fund Budget for the Authority members. The Regional Revenue Fund Budget is the source for transportation project funding by the Authority.
- ✓ Mr. Longhi stated that NVTA will not be issuing bonds.
- ✓ Total Recommended Project Appropriation Requests are \$298,800,000, which includes forward appropriations. If future revenues are diverted, projects will likely require cancellations.
- ✓ Mayor Rishell made a motion, seconded by Chairman McKay, to approve the Regional Revenue Fund Budget as presented. The motion was approved unanimously.

# 6. Adoption of the FY2025 Operating Budget

Mayor Rishell, Finance Committee Chair

- ✓ Chief Financial Officer Michael Longhi presented the budget noting the Operating Budget is the central accounting point for operating and administrative expenses of the Authority. He presented changes to the base budget related to inflation and contract escalations. He then discussed the proposed new initiatives for FY2025.
- ✓ It was noted that the proposed new initiatives would improve project initiation and timely delivery.
- ✓ There was discussion among Authority members regarding how new initiatives could assist the project sponsors in advancing project delivery. There was also a discussion on the risk of having allocated funding diverted if projects are not advancing on a timely basis.
- ✓ Mr. Longhi noted that additional positions will allow NVTA to have the resources dedicated to collaborate with project sponsors on a regular basis to ensure projects move along at a reasonable pace.
- ✓ The update to the Authority's Strategic Plan and how that can bring forward improvements to timely project initiation and delivery were also discussed.

✓ Mayor Rishell made a motion, seconded by Chair Randall to approve the Operating Budget as presented. The motion was approved unanimously.

# 7. Approval of the Programming Recommendations of the Additional FY2025-2030 CMAQ/RSTP Funds Ms. Backmon, Chief Executive Officer

Dr. Nampoothiri, Senior Manager, Transportation Planning and Programming

- ✓ Ms. Backmon noted that at the March 14, 2024, Authority meeting, the Authority approved recommendation to the Commonwealth Transportation Board (CTB) of the FY2030 Congestion Mitigation Air Quality Improvement Program (CMAQ) and Regional Surface Transportation Program (RSTP) funding recommendations. Since the March meeting, adjustments to the CMAQ/RSTP funds available have been made. NVTA staff worked with the Regional Jurisdiction and Agency Coordinating Committee (RJACC) to identify projects where these additional funds are to be allocated. The RJACC approved the changes at its March 28, 2024, meeting.
- ✓ Mayor Wilson made a motion, seconded by Council Member Snyder, to approve the additional programming recommendations for CMAQ/RSTP Funds. The motion was approved unanimously.

# 8A. Approval of Recommendation to Reallocate Congestion and Mitigation and Air Quality Improvement Program (CMAQ) Funds for Prince William County

Ms. Backmon, Chief Executive Officer

- ✓ Ms. Backmon noted that Prince William County requested a transfer of \$472,000 CMAQ funds from UPC T21486 (John Marshall Highway/Route 55 Sidewalk) to UPC 122042 (Ellicott Street Sidewalk / Occoquan Greenway Connection). She stated this transfer required Authority approval, and the RJACC recommended approval of the request. She also noted that Prince William County made an additional request to transfer \$1,000,000 of CMAQ funds from UPC T21486 (John Marshall Highway/Route 55 Sidewalk) to UPC 112463 (Prince William Parkway Sidewalk) which only required RJACC approval. The RJACC approved this transfer recommendation request at its March 28, 2024, meeting.
- ✓ Chair Jefferson made a motion to approve the reallocation of \$472,000 CMAQ funds from UPC T21486 to UPC 122042 for Prince William County, seconded by Mayor Rishell. The motion was approved unanimously.

- ✓ Ms. Backmon stated on April 5, 2024, NVTA received a request for endorsement from Fairfax County on their application under the U.S. Federal Transit Administration's Low or No Emission Grant Program and Bus and Bus Facilities Discretionary Grant program.
- ✓ Chairman McKay made a motion, seconded by Board Member Karantonis to approve a letter of endorsement for Fairfax County's Low or No Emission Grant Program and Bus

and Bus Facilities Discretionary Grant Application. The motion was approved unanimously.

- ✓ Chair Randall called on Senator Boysko to give an update on the General Assembly Session. Senator Boysko stated that local businesses and local governments should be using their voices to express their sentiments to the governor regarding his proposed amendments to the budget.
- ✓ Authority members discussed the Governor's Budget Amendment #179 which upends the state funding towards WMATA approved by the General Assembly in House Bill 30. Conversations focused on concerns of the administration's understanding of how Northern Virginia funds WMATA and the impact and long-term sustainability needs of funding the system.
- ✓ On a motion by Vice Chair Snyder, seconded by Council Member Smith, Chair Randall was authorized to send a letter to the General Assembly in substantial conformance with the circulated draft urging the General Assembly to oppose Budget Amendment 179. The motion was approved unanimously.

**1. Purpose:** To seek Northern Virginia Transportation Authority (NVTA) endorsement of Arlington County's Active Transportation Infrastructure Investment Program (ATIIP) grant application.

- **2. Suggested Motion:** I move Authority approval of the letter of endorsement for Arlington County's Active Transportation Infrastructure Investment Program (ATIIP) grant application.
- 3. Background: As is customary among NVTA partnerships, requests for the Authority's endorsement are received from jurisdictions and regional agencies embraced by the Authority. To help fund their transportation projects, jurisdictions and regional agencies pursue sources of funding through federal, state, and regional programs and grants. Per the Code of Virginia, NVTA serves as an advocate for the transportation needs of Northern Virginia before the state and federal government. NVTA has received a request for endorsement from Arlington County on their application under the U.S. Department of Transportation (DOT)'s FY2023 Active Transportation Infrastructure Investment Program (ATIIP) discretionary grant program.
  - A. Active Transportation Infrastructure Investment Program (ATIIP) grant program: Section 11529 of the Bipartisan Infrastructure Law (BIL) established ATIIP to provide discretionary grants to eligible entities to plan, design, and construct eligible projects that provide safe and connected active transportation infrastructure in an active transportation network. ATIIP projects will help improve the safety, efficiency, and reliability of active transportation networks and communities; improve connectivity between active transportation modes and public transportation; enhance the resiliency of on- and off-road active transportation infrastructure and help protect the environment; and improve quality of life in disadvantaged communities through the delivery of connected active transportation networks and expanded mobility opportunities.

## **B.** ATIIP Program Criteria:

Two types of applications are considered:

- Planning and design projects: a total cost of at least \$100,000 and a maximum cost of \$2 million is recommended.
- Construction projects: a total cost of at least \$7.5 million and a maximum cost of \$12 million is recommended.

The project should address the DOT's strategic plan goals of safety, equity, climate and sustainability, and workforce development, job quality, and wealth creation. Merit criteria include mobility and community connectivity, community support, commitment to increasing walking, biking, and other types of active transportation, financial completeness, and equitable development.

4. Project Scope Under Arlington County's ATIIP Application: Through the ATIIP, Arlington County intends to apply for up to \$2 million in planning/design funding for the South George Mason Drive Segments 2 and 3 project. This project will reconfigure South George Mason Drive between Columbia Pike and the Fairfax County line to add safer, more accessible bicycle and pedestrian travelways, and to reconfigure intersections to be safer for all users. The project traverses two Arlington County Vision Zero Hot Spots and includes a potential innovative intersection at Four Mile Run Drive.

- 3. Background: As is customary among NVTA partnerships, requests for the Authority's endorsement are received from jurisdictions and regional agencies embraced by the Authority. To help fund their transportation projects, jurisdictions and regional agencies pursue sources of funding through federal, state, and regional programs and grants. Per the Code of Virginia, NVTA serves as an advocate for the transportation needs of Northern Virginia before the state and federal government. NVTA has received a request for endorsement from Arlington County on their application under the U.S. Department of Transportation (DOT)'s FY2024 Safe Streets and Roads For All (SS4A) discretionary grant program.

# A. Safe Streets And Roads For All (SS4A) Grant Program:

The Bipartisan Infrastructure Law (BIL) established the SS4A Grant Program with \$5 billion in appropriated funds over five years (2022 to 2026). The program supports the development of a comprehensive safety action plan (Action Plan) that identifies the most significant roadway safety concerns in a community and the implementation of projects and strategies to address roadway safety issues. The application deadline is 5 p.m. ET on Thursday, May 16, 2024. As of the last update on the program's web page (<a href="https://www.transportation.gov/grants/SS4A">https://www.transportation.gov/grants/SS4A</a>), over \$3 billion is still available for future funding rounds.

# B. SS4A Program Criteria:

Under this program, there are three broad categories of funding opportunities:

- Comprehensive Safety Action Plans
- Planning And Demonstration Activities
- Implementation Grants

Arlington County's application is for the first item above. In this grant program, comprehensive safety action plans (referred to as "Action Plans") are the basic building

block to significantly improve roadway safety. Action Plans are comprehensive safety plans aimed at reducing and eliminating serious-injury and fatal crashes affecting all roadway users. The SS4A grant program is guided by the Safe System Approach, which involves a paradigm shift to improve safety culture, increase collaboration across all safety stakeholders, and refocus transportation system design and operation on anticipating human mistakes and lessening impact forces to reduce crash severity and save lives.

4. Project Scope Under Arlington County's SS4A Application: Through the SS4A program, Arlington County intends to apply for up to \$16 million for the Arlington Boulevard/ Washington Boulevard Interchange Access Improvements project. This project will reconfigure interchange ramps on to and off of Arlington Boulevard (US 50) and Washington Boulevard (VA 27) to straighter, safer ramps, with new traffic signals, improved merges and improved crossings. This is the highest crash location in Arlington County year after year, making it a high priority for safety-related improvements.

Application

1. Purpose: To seek Northern Virginia Transportation Authority (NVTA) endorsement of Prince William County's Nationally Significant Multimodal Freight and Highway Projects Grants Program (INFRA) application.

- **2.** Suggested Motion: I move Authority approval of the letter of endorsement for Prince William County's Nationally Significant Multimodal Freight and Highway Projects Grants Program (INFRA) application.
- 3. Background: As is customary among NVTA partnerships, requests for the Authority's endorsement are received from jurisdictions and regional agencies embraced by the Authority. To help fund their transportation projects, jurisdictions and regional agencies pursue sources of funding through federal, state, and regional programs and grants. Per the Code of Virginia, NVTA serves as an advocate for the transportation needs of Northern Virginia before the state and federal government. NVTA has received a request for endorsement from Prince William County on their application under the U.S. Department of Transportation (DOT)'s FY2025-2026 Multimodal Project Discretionary Grant (MPDG) program. The MPDG opportunity contains three grant programs: the National Infrastructure Project Assistance Grants Program (Mega), the Nationally Significant Multimodal Freight and Highway Projects Grants Program (INFRA), and the Rural Surface Transportation Grant Program (Rural). Prince William County has informed NVTA of their intent to apply for INFRA funds.

# A. Nationally Significant Multimodal Freight and Highway Projects Grants Program (INFRA):

The funding opportunities are awarded on a competitive basis for surface transportation infrastructure projects – including highway and bridge, intercity passenger rail, railway-highway grade crossing or separation, wildlife crossing, public transportation, marine highway, and freight projects, or groups of such projects – with significant national or regional impact.

## B. INFRA Criteria:

Key program objectives for INFRA include:

safety

- state of good repair
- economic impacts, freight movement, and job creation
- climate change, resilience, and the environment
- equity, multimodal options, and quality of life
- innovation areas: technology, project delivery, and financing
- economic analysis rating
- project readiness rating
- 4. Project Scope Under Prince William County's INFRA Application: Through the INFRA program, Prince William County intends to apply for the Route 123 Old Bridge Road Intersection Improvements project. The Route 123 Old Bridge Road Intersection Improvements have been adopted in NVTA's long-range plan, TransAction (ID 383), and have been previously endorsed by the Authority for application for federal discretionary grant funding. The project will construct a grade separated flyover ramp from northbound Route 123 to westbound Old Bridge Road. This intersection improvement will improve safety by eliminating dangerous weaving movements and will also reduce overall delay and congestion at the intersection. The project will further key shared state and federal transportation goals, including providing multimodal transportation options for underserved communities by improving travel time reliability for local and commuter bus routes and constructing pedestrian and bicycle facilities, in addition to improving operations for vehicles. The project is currently in design. Approximately \$15.8 million in NVTA Local Distribution Funds (30%) and federal Regional Surface Transportation Program (RSTP) funds have been allocated to the project.

**1. Purpose:** To inform the Northern Virginia Transportation Authority (NVTA) on recent activities of the NVTA Planning and Programming Committee (PPC).

**2. Background:** The Planning and Programming Committee met on April 8, 2024, at 5:00 p.m. The meeting was held virtually via Zoom, with four members present. The meeting was livestreamed on YouTube.

### 3. Action Items:

**A. Summary Notes of November 21, 2022, Meeting:** The meeting summary for the November 21, 2022, meeting was approved unanimously.

### 4. Discussion Items:

- A. FY2024-2029 Six Year Program (SYP) Update: Dr. Nampoothiri provided an overview of the SYP process at NVTA, outlining a framework comprising both quantitative and qualitative metrics to guide project funding recommendations. During this session, he presented analytical results for all metrics, including Congestion Reduction Relative to Cost (CRRC), TransAction Rating, long term benefit and qualitative measures pertaining to candidate projects within the FY2024-2029 SYP. Emphasizing the legal significance of Congestion Reduction Relative to Cost (CRRC) scores, he highlighted that projects are primarily ranked based on this criterion. He noted that the evaluation results and project details are currently published for public comment, which will continue until May 19, 2024. He added that staff recommendations will be developed after the public comment period is over and all the public comments received have been evaluated.
- B. Preliminary Deployment Plan for Regional Bus Rapid Transit (BRT) System: Mr. Jasper provided an update on the progress of the Preliminary Deployment Plan for a Regional Bus Rapid Transit system (PDP-BRT). The PDP-BRT will serve to protect the nearly \$500 million investments that NVTA has already made in all the five BRT lines in Northern Virginia currently under development, as well as ensure that future BRT investments will be complementary and synergistic. The PDP-BRT kicked off on October 31, 2023, and various activities are currently underway or completed. Mr. Jasper presented the results related to BRT from the perception survey by pointing out people's familiarity and favorability of BRT, how people might use BRT, and the top influential benefits of using BRT. Mr. Jasper also discussed the role of stakeholder engagement throughout the PDP-

BRT, through the BRT Planning Working Group. The group includes staff of member jurisdictions and other public agencies involved with transit planning across the Northern Virginia, Washington D.C, and Maryland. Further, Mr. Jasper provided the schedule and phased approach of the PDP-BRT. The first phase of the schedule, Data Gathering, is coming to an end in June/July 2024. Phase 2, Analysis, will begin in July 2024, and is anticipated to conclude in February 2025.

- **C. NVTA Update:** Ms. Backmon mentioned that NVTA's new address is 2600 Park Tower Drive, Vienna, and the next Authority meeting will be held in-person at this new office location. Ms. Backmon reminded the PPC members that NVTA's FY2025 budgets adoption is anticipated at the April 11, 2024, Authority meeting.
- **5. Next Steps:** The next scheduled meeting for the PPC is Monday, May 6, 2024, at 5:00 p.m. This meeting will be held in the first-floor conference room at the new NVTA Offices at 2600 Park Tower Drive.

**SUBJECT:** Chief Executive Officer's Report

**1. Purpose:** To inform the Northern Virginia Transportation Authority (NVTA) of items of interest not addressed in the agenda.

### 2. Discussion Items:

A. Preliminary Deployment Plan for a Regional Bus Rapid Transit System in Northern Virginia (PDP-BRT): The PDP-BRT will refine and evaluate the BRT system identified in the current version of TransAction adopted in December 2022. The PDP-BRT will serve to protect the nearly \$500 million investment that NVTA has already made in all five BRT lines in Northern Virginia, as well as ensure that future BRT investments will be complementary and synergistic. The PDP-BRT kicked off on October 31, 2023, and various activities are currently underway or completed. NVTA launched a PDP-BRT webpage in early February (https://thenovaauthority.org/brt).

Following the presentation of the findings of a Perception Survey to the Authority at its February meeting, four virtual focus groups with Northern Virginians were held in early March, providing deeper insights into various topics related to the factors that may influence future willingness to use a regional BRT system. A second wave of focus groups will be held in later phases of the PDP-BRT.

The team is finalizing an online survey, to be deployed on May 20, 2024. This survey will further explore topics raised in the earlier perception survey and focus groups with a broader range of Northern Virginians.

Additional work includes increasing business engagement, and the team will continue to review BRT studies and projects across the country to develop lessons learned and best practices related to maximizing ridership, cost-effective operations, funding, and governance options that could be transferable to the regional BRT system.

NVTA staff and the consultant team will provide the Authority with the key findings of the focus groups, online survey, and an understanding of where Northern Virginia fits regarding BRT deployment compared to a nationwide peer group in two parts at the upcoming June and July Authority meetings. Additionally, the team will engage with the Authority so members can share their own thoughts on what the team needs to consider prior to the start of the analytical work.

Following the initial round of community engagement, analytical work will commence in July 2024 and continue through March 2025, followed by a further round of public engagement in spring 2025.

B. Successful Grant Application for the Promoting Resilient Operations for Transformative, Efficient, and Cost-Saving Transportation (PROTECT) Program: The U.S. Department of Transportation (USDOT) recently announced that Virginia Department of Transportation (VDOT) has been awarded \$5.4 million under the PROTECT Program. In August 2023, the Authority endorsed VDOT's Office of Transportation Sustainability grant application to USDOT's PROTECT Program. VDOT was applying for a pilot program in the Tidewater and Chesapeake region known as the Modernizing Operations for Virginia's Evacuation Resilience (MOVER) initiative. The pilot program will be the first step towards a comprehensive statewide integrated technology initiative that will help ensure efficient traffic flow on critical routes during emergency weather events and create a more resilient evacuation network in Virginia. The MOVER initiative will address critical gaps in climate measurement and monitoring technology coverage along evacuation routes, at facilities that support emergency evacuation, at connections to important emergency facilities, and along routes that serve traditionally underserved communities.

While the pilot program will not include Northern Virginia, NVTA nonetheless supports and endorsed the MOVER initiative because of its potential future implementation in our region. Additionally, this demonstrates NVTA's interest in transportation technology and the importance of transportation resiliency in our long-range transportation planning efforts. NVTA staff will monitor progress and report on the development of the program.

- C. Active Transportation Infrastructure Investment Program (ATIIP) Grant Application:

  NVTA staff are coordinating with staff from Prince William County, the Cities of

  Manassas and Manassas Park, and Virginia Railway Express (VRE) to develop an ATIIP

  planning/design grant application for up to \$2 million to the USDOT. If successful, the

  grant will provide funds to develop the first phase of a trail that could eventually run

  from the City of Manassas to the City of Alexandria, generally following the VRE

  Manassas Line alignment. This project is included in the current version of TransAction,

  (ID 439: VRE Manassas Line Trail Landmark to City of Manassas). Prince William County

  has agreed to be the lead applicant. The deadline for the grant application is June 17,

  2024, and NVTA staff will be requesting approval of an Authority letter of endorsement

  at its June 13 meeting.
- D. Bike to Work Day 2024: On Friday, May 17th, NVTA staff will be participating in the Bike to Work Day 2024 activities at the Gateway Park pit stop in Rosslyn, Arlington, from 7:00 to 9:00 a.m. For last year's event, Gateway Park led all Northern Virginia's 55 pit stops in number of registrations accounting for over 600 participants.
  NVTA's participation in Bike to Work Day provides a valuable opportunity to raise awareness of NVTA's primary responsibilities long-range transportation planning and funding multimodal projects throughout the region as well as other ongoing initiatives such as the PDP-BRT. Additionally, this year's Bike to Work Day event occurs during the public comment period for the FY2024-2029 Six-Year Program (SYP), allowing NVTA staff to raise awareness of this important public comment opportunity.

- E. Presentation to Catholic University of America: On April 25, 2024, Ian Newman, AICP, Regional Transportation Planner, gave a presentation to students in the *Intro to Geographic Information Systems (GIS)* course within the Department of Civil and Environmental Engineering at Catholic University of America. Mr. Newman spoke about how he utilizes GIS for various transportation planning efforts; for geospatial data visualizations and analytics in equity, safety, sustainability, and public involvement; and how transportation planning and GIS are related. Drawing on his background in GIS, Mr. Newman shared personal insights for students interested in pursuing GIS as part of their future careers.






